## **ACTIVITY SNAPSHOT: JANUARY - MARCH 2023**



As part of an Innovate UK funded initiative, ABHI partnered with CPI to deliver the most comprehensive SME study to date. The report, which was supported by a launch event in Westminster. can be **accessed here**, and is being used to assess how we can further enhance our own offer to SMEs

## The Secretary of State led Life Sciences Council established an advisory group

consisting of the heads of ABHI, the MHRA, Office for Life Sciences and the Department of Health and Social Care MedTech Directorate, to agree on aligned proposals to deliver the UKCA process effectively.

- ABHI ran a weekly series of communications and engagement webinars for members.
- After two months of discussions. aligned proposals were published.

We announced the first set of nominations for the **Innovation in HealthTech**: **Recognising Excellence** campaign, which is aimed at highlighting and celebrating excellence in HealthTech innovation across the country.

Considering Carbon Reduction Plans (CRPs), we held a webinar for members on preparedness for this key sustainability milestone. A recording of the session, can be **accessed here.** Working with NHS colleagues, we have also developed a comprehensive set of FAQs to support CRPs.

Coinciding with International Women's Day, ABHI launched a gender equality survey, specific to the HealthTech industry. This will be run annually so that we can track progress, and share best practice, over time.



On 27<sup>th</sup> February, we ran our latest member briefing. The sessions are an ideal way for any new starters in your business to understand the role of ABHI, and the breath of our activities.

Discussing the shift from policy to practice, ABHI's digital health <u>report</u> set out the system changes needed to better enable digital technologies to address the NHS's most pressing challenges.

ABHI responded to key consultations on behalf of industry, including the 2023/25 NHS Payment Scheme, the UK's research and development tax relief scheme, and the International Trade Committee Inquiry into export opportunities.

ABHI's extensive sustainability support was also recognised at this year's Trade Association Forum Awards, where we were delighted to have been shortlisted for the ESG Initiative of the Year.

Identifying the challenges and opportunities associated with meeting sustainability requirements, ABHI led a series of roundtable meetings with members, with a view to informing a report that will be launched later this year.









Working with KPMG, we ran a Q&A session for members, looking at how businesses can navigate and make the most of innovation relief and incentives schemes in the UK.

ABHI's US Accelerator 2023 programme kicked off this guarter, with the latest delegation heading to Texas, before visits to Tennessee, California and Florida later this year. Now in its sixth year, the programme continues to grow, and has generated millions of dollars in investment for UK businesses.

Back at the Middle East's largest healthcare expo, the **ABHI UK Pavilion welcomed over 150 organisations** at Arab Health 2023. With 136,800 attendees, this was ABHI's most impactful pavilion to date, as we provided exhibitors with a comprehensive support package, enabling them to enter and expand business within the region. We also hosted 40 presentations and surgical demonstrations on our stand.

Joining the cast of speakers at **Rewired 2023**, Andrew Davies spoke to delegates about the Convergence of Digital Health and Medical Devices.



Partnering with Media Planet on their **Future of Healthcare campaign**, Addie MacGregor wrote about the role of HealthTech in delivering more sustainable outcomes, in a piece that was published in the Guardian.



ABHI's regulatory Directors led a series of updates to members and stakeholders on the current state of play of the development of a **new UK regulatory framework**, including two 'ask the experts' webinars.





Steve Lee presented to the **Mexican Ministry of Health** on how trade associations can work successfully with regulatory authorities. And continuing in a series of education events, Steve presented at InformaConnect IVD School, sharing expertise on the regulatory process.





Conveying important messages on **R&D Tax Credits**, ABHI constituted a roundtable meeting with Health Ministers Will Quince and George Freeman, and Financial Secretary to the Treasury, Victoria Atkins.



ABHI member McDermott Will & Emery led a refresher session for companies on **Competition Law,** focussed on best practice when working on topics that may be commercially sensitive.





Parliamentary engagement continued, with roundtable meetings on the Ministerial MedTech strategy, a Chancellor sponsored Digital Health Therapeutics session, and a meeting with Robert Ede, the Special Adviser to Health Secretary Steve Barclay.



A number of ABHI members were invited to attend the Chancellor's first ever Treasury Connect: Life Sciences conference, enabling industry leaders to discuss how best to support growth across the life sciences industry.
