ABOUT REHACARE:

Rehacare is the No 1 Trade Fair for rehabilitation, prevention, integration, care and assistive technologies products in the world. The exhibition covers a wide range of rehabilitation equipment and supplies as well as aids for daily living.

Rehacare is a decision-makers event. 70% of the visitors are from the trade, nearly half of whom report having direct purchasing authority.

In 2008 758 exhibitors from 29 countries exhibited at Rehacare with the UK the largest international presence with over 50 companies exhibiting. There were 52,000 visiting professionals attended the four day show, an increase of 10% of 2007 figures.
