
## WHAT IS HEALTHTECH?



## ABHI BUSINESS SURVEY: THE STRENGTHS



Exports to the US are expected to **increase** in 2019

The sector remains resilient, with **95%** of businesses expecting to either **increase** or **maintain investment in the UK** 





**56%** of companies expect **staffing numbers to grow** in 2019, a **3% increase** on 2018

With a **4% increase**, more non-exporting companies aim to **begin exporting in 2019** 



## ABHI BUSINESS SURVEY: The challenges



The biggest barriers to growth in 2019 are: uncertainties caused by Brexit and procurement challenges

Concerns around implementation of the new regulations and innovation adoption have also increased





Confidence in the NHS as a place to launch innovations has fallen. **19% see low innovation adoption** as their biggest barrier to growth, compared to **12% in 2017** 

Growth forecasts have dropped. 61% of companies expect growth in 2019, compared to 73% when asked the same question 12 months ago



83 Members completed the survey, of which 73% were SMEs
